

2025 Oratorical Contest

LEGION FAMILY, it's time to start preparing for your upcoming oratorical contest if you have not started yet. This year I am going to provide you with the documents that will HELP kick start your program.

The attached Chairman's guide will give you guidance, examples, and the info you will need to run your program. I have also attached a few other useful documents. If there is anything in the guide that you cannot achieve due to physical restraints or personnel you may have to substitute or work around, but you need to make sure you do not compromise the integrity of the contest. If you have questions, please ask so that we can work together to suggest a work around that will not compromise your program's integrity. You have four months to start getting your program set up.

One suggestion that I would like to make is that you need to start now looking for your judges. Don't make this hard! Read the Chairman's guide and contact your choices as early as possible to give them time to fit us into their schedule.

Please remember we are here to assist you in running your program. I am always available as well as members of the committee to assist you. Please call or email as soon as you determine that you may be running into a problem so we can get ahead of them.

Don't forget, we still need the contact information of your oratorical poc. We will be adding the miscellaneous forms that will be needed to run your contest that are not in the guide to the webpage.

Comments from the Department Judge Advocate

Good day to all my Veteran brothers and sisters.

We are a third of the way through the forth calendar quarter of the year with a busy several months ahead. At the first of the year or shortly thereafter, each post, district and the department will be concerning themselves with who will lead these pieces of our state legion. As you have already seen, there are resolutions in for Jr. Vice Commander of the Department as well as two Division officer candidates already declaring. There will be many more in the next couple of months leading up to our Mid-Winter Conference. These are extremely important positions. That said, probably more importantly, are those Legionnaires you will be selecting to lead your posts and districts. We are a bottom-up organization as I have said many times before. The strength of our organization and the thousands of Veterans in Alabama we support, begins at the Post level. They are the foundation for a great American Legion Department of Alabama.

That brings me to the primary subject of this short article. I know many of you will say "I have heard this before". And hopefully you have. I know I've said it many times to whoever will listen to me. Officers, regardless of the position, should be selected for their ability to perform the work of the office to which they are elected. They should not run for office due to any real or perceived social prestige or what color hat they will wear. Having knowledge of the work of the legion and having enthusiasm for its purposes is extremely important. They should also have an innate sense of fairness, justice and courtesy as well as open-mindedness, moral courage and the ability to get along with people. Every level of the

legion should be working towards the goals. mission and objectives of the organization. Understand, "willingness to serve" is not enough. You should ask are the candidates fit to serve? What does that mean? That means they will be able to carry out the duties of the position and lead at that respective level. What are other considerations? They must be a member in good standing and have sufficient knowledge of The American Legion history, policies, and programs. Be assured, whatever position a legionnaire is running for, at some point, you will be asked to explain to a non-member "what is the Legion all about" and "why should I join". Additionally, candidates should demonstrate regular attendance at their respective Post. Having a good working knowledge of the activities and the financials of the posts, etc., is also a must.

In short, we as legionnaires should put much thought into who will be our candidates for election and ultimately, our officers. We, as members, hold this responsibility in our hands. It is up to us to make it a reality and participate in the growth of our American Legion. Thank You and God Bless each of you and God Bless America.
